Why consider property investment?

- Gearing: It is quite easy to gear (borrow) against an investment property enabling your
 investment dollars or equity to go further. Ie you can borrow up to 95% of a property
 valuation from many lenders allowing you to make your investment dollars go further. You
 can also leverage of equity that you have in your own property already resulting in buying
 a house with none of your own cash required.
- 2. **Cash Flow:** The rent from the tenant and the tax deductions available to the investor can cover the majority of the cost of ownership of an investment property over time.
- 3. **Tax Deductions**: By claiming the depreciation on a property and other expenses in holding that property, you can effectively have the ATO fund part of the ownership costs of owning an investment property.
- 4. **Growth**: Due to the gearing that you can achieve on an investment property, the capital growth can have a dramatic effect based on your original investment amount.


